APPROVAL ON THE QUALIFICATION OF DIRECTOR BY THE REGULATORY AUTHORITY

References are made to the announcement dated March 28, 2025, the circular of the 2024 annual general meeting (the “**AGM**”) dated May 23, 2025 and the announcement of the poll results of the AGM dated June 13, 2025 (the “**Announcements and Circular**”) of Guangzhou Rural Commercial Bank Co., Ltd.* (the “**Bank**”).
